### NOTIFICATION

In pursuance of sub-section (1) of section 10 of the Delimitation Act, 2002 (33 of 2002), the following Order made by the Delimitation Commission under sub-section (2) of section 9 read with sub-section (2) of section 4 of the Act, in respect of the delimitation of Parliamentary and Assembly Constituencies in the Union Territory of Pondicherry (hereinafter referred to as UT) is hereby published.

### ORDER NO.6

Whereas, in pursuance of sections 8, 4 and 2(f) of the Delimitation Act, 2002 (33 of 2002), as amended by the Delimitation (Amendment) Act, 2003 (3 of 2004), the Delimitation Commission has, by its Order No.1 dated 8<sup>th</sup> October, 2004, published in the extraordinary issue of the Gazette of India and the Gazette of Pondicherry on 8<sup>th</sup> October, 2004, determined - (i) the total number of seats in the House of the People to be allocated to the Union Territory of Pondicherry as one (1), of which no seat shall be reserved for the Scheduled Castes and also no seats shall be reserved for the Scheduled Tribes, and (ii) the total number of seats to be assigned to the Legislative Assembly of the Union Territory of Pondicherry as thirty (30), of which five (5) seats shall be reserved for the Scheduled Castes and no seats for the Scheduled Tribes; and

Whereas, in pursuance of sub-section (1) of section 5, read with sub-section (1) of section 9 of the said Act, the Delimitation Commission associated with itself the Associate Members from the UT with the proceedings for the delimitation of Parliamentary and Assembly Constituencies in the UT; and

Whereas, in pursuance of sub-section (2) of section 9 of the said Act, the Delimitation Commission published its proposals, along with the dissenting proposals of the Associate Members of the Commission, who desired publication thereof, for the delimitation of Parliamentary and Assembly Constituencies in the Union Territory, in the extraordinary issues of the Gazette of India and the Gazette of Pondicherry on 8<sup>th</sup> October,2004 and 8<sup>th</sup> December, 2004, for inviting objections and suggestions in relation to the aforesaid proposals by 25<sup>th</sup> October,2004 and 20<sup>th</sup> December, 2004 respectively; and

Whereas, in pursuance of the said sub-section (2) of section 9 of that Act, the Commission's Order No.1 mentioned above and the above referred draft proposals of the Commission along with the dissenting proposals of the Associate Members were also published in the local newspapers on 9<sup>th</sup> October, 2004 and 8<sup>th</sup> December, 2004 and given further publicity through radio and television and other media of mass communication; and

Whereas, in pursuance of the said sub-section (2) of section 9 of that Act, the Commission also issued a public notice on 8<sup>th</sup> October, 2004 which was subsequently amended by its revised notices on 1.11.2004, 8.12.2004, 4.1.2005 and 25.1.2005, specifying the venue, date and time of public sittings to consider all objections and suggestions which may be received by it on or before the 25<sup>th</sup> October, 2004 and 20<sup>th</sup> December, 2004; and

Whereas, in pursuance of the said sub-section (2) of section 9 of that Act, the Commission held public sittings at Karaikal on 19<sup>th</sup> March, 2005 and at Pondicherry on the 20<sup>th</sup> March, 2005, and heard the members of the public and afforded them full opportunity of making oral and written submissions, in addition to the written representations already sent, if any, to the Commission; and

Whereas, the Commission has considered all objections and suggestions made at the aforesaid public sittings and/or received by it otherwise, in relation to its said proposals, in the light of the relevant provisions of the Constitution and the said Act;

Now, therefore, in pursuance of clause (d) of sub-section 2 of section 9 read with sections 2(f) and 4 (2) of the said Act, as amended, the Delimitation Commission hereby determines as follows:-

1. The territorial assembly constituencies into which the Union Territory of Pondicherry shall be divided for the purpose of elections to the Legislative Assembly of the Union Territory and the extent of each such constituency shall be as shown in **Table A**.
2. The extent of territorial parliamentary constituency in respect of the Union Territory of Pondicherry for the purpose of elections to the House of the People shall be as shown in **Table B**.
3. Where the name of a constituency as shown in **Table A** is distinguished by the brackets and letters "(SC)" the seat in that constituency is reserved for the Scheduled Castes.
